1. All applications must be made on the application form. The application form can either be obtained from the Club office or downloaded from the Club's website. All corrections to mistakes made on the form must be initialled.
2. All applications must be submitted fully completed and unless otherwise indicated in the application form, all sections and blanks are to be filled up accordingly. The Club will not entertain partially completed application forms.
3. The Club may ask for further information or documentation to be furnished. If such request is not met within the time period given by the Club, the Club will treat the application as incomplete and is not obliged to entertain such application.
4. One colour passport size photograph is to be affixed to the application form. Two additional colour passport size photographs are to be submitted together with the application. The applicant's name should be written clearly on the back of all photographs submitted.
5. The application must be accompanied by full payment of the first annual subscription fee. Applications for junior membership must also include an executed letter of guarantee and indemnity form.
